

AvePoint Accessibility Accelerator 1.0

Release Notes

New Features and Improvements

- Optimized accessibility of the SharePoint 2010 built-in master pages through activating the **AccessibilityAdapterForSharePoint2010** feature.
- Availability of the text resizing function in an Internet Explorer (IE) browser on the master page with AvePoint Accessibility Accelerator style sheets.
- Control adapters to facilitate accessibility and ensure that output of the Web parts and elements are accessible.
- Customizable capability to modify the content of a webpage to correct for accessibility or validation of HTML or XHTML.
- Management of the AvePoint Accessibility Accelerator license in SharePoint Central Administration's License Management page.

Known Issues

- The master page feature cannot resize the text of the Assets Web Database, Charitable Contribution Web Database, Contact Web Database, Issues Web Database, or the Project Web Database sites.
- The master page feature does not support resizing text on the webpage dialog.
- After uninstalling AvePoint Accessibility Accelerator, all websites with control adapters applied cannot be accessed. Before you uninstall, navigate to **Central Administration > Control Adapter Management** and set the **Control Adapter** field to **N/A** for the Web applications in the SharePoint farm, or delete the elements you added to the **compat.browser** file.
- While activating the AvePoint Accessibility Accelerator features on a site collection:
 - If you create a managed metadata column in List Settings, resize the text in an IE browser, and browse the default value for this column, then the text on the pop-up page cannot be resized by the master page feature. The pop-up window still uses the SharePoint built-in style sheet, and it does not inherit the applied AvePoint master page.
 - If you create a new calendar list and resize the text in an IE browser, the text of the date and time drop-down list cannot be resized by the master page feature. The date and time drop-down list still uses the SharePoint built-in style sheet, and it does not inherit the applied AvePoint master page.
 - If you resize the text in an IE browser and upload a document to SharePoint, the text on the processing window cannot be resized by the master page feature. This window is initialized as another page, which is not under the control of the applied master page.
- While activating the AvePoint Accessibility Accelerator features on a team site collection:
 - If you resize the text in the IE browser and navigate to **Site Settings > Reporting Service > Manage Shared Schedules, and Site Settings > Reporting Service > Reporting Services Site Settings**, then the text on the Manage Shared Schedules page and the Reporting

Services Site Settings page cannot be resized. The two pages applied the fixed application.master page, and it does not change to the applied AvePoint master page.

- If you resize the text in an IE browser and navigate to **Site Settings > Site Collection Administration**, then the text on the Search Settings, Search Scopes, and Search Keywords pages cannot be resized. The three pages separately apply the application.master page, so the text does not change with the applied AvePoint master page.
- If you resize the text in an IE browser, navigate to **Site Actions > Site Permissions** to view the users and groups of this site collection, and select a group, then you will be brought to the People and Groups page to view the group members. Navigate to **Settings > List Settings > Generate file plan report** to specify where to save the report once it has been generated. Click **Browse**, and the text in the pop-up window cannot be resized. The master page feature does not support to resize the text on the webpage dialog.
- If you resize the text in an IE browser and navigate to **Site Action > Manage Site Content and Structure**, then the text on this page cannot be resized. This page separately applies another master page. Therefore, the master page you applied later does not affect this page.
