## Release Notes

Service Pack 3, Cumulative Update 2

## New Features and Improvements

- Added support to allow deletion of backup data at the same time as backup job records.
- Customer device usage reports are now available to download by navigating to **DocAve Online Dashboard > Storage Usage**. These reports display storage usage from Azure, DocAve Online, and SharePoint Online in Office365.
- Content Manager, Replicator, and Granular Backup and Restore now support the per-location view settings of a list.
- Rackspace Cloud File is now supported as a storage type when configuring a physical device in Control Panel.
- Added support to import a pre-defined configuration file for batch setting changes.

## Known Issues

- When configuring a filter policy for the **Number** column with a percentage, the column value must be in a decimal format instead of a percentage in order for the filter policy to be configured correctly and properly run any jobs.
- When merging a source site to a destination site collection, the source site administrator is not promoted to the destination site collection administrator, and therefore the source site administrator cannot access the destination site collection. The source site inherits permissions from its site collection. As a workaround, copy/move all of the source permissions to the destination, and select the source site collection as the source node.
- Office 365 currently does not support restoring folder versions, so discussion subjects are regarded as folders by Office 365. If you perform a Granular Backup to back up a site that contains a discussion board, run a restore job to out of place restore the backed up site to a site collection, and select **Attach** as the **Action**, **Merge** as the **Container level conflict resolution**, and **Overwrite** as the **Content level conflict resolution**, the restore job only restores one item version of the discussion subject to the destination.
- Site language settings cannot be backed up or restored due to a limitation of SharePoint API. **SharePoint API. SharePoint.Client.Web** does not have the `AlternateUICultures` attribute. For example, if you configure the language settings in a source team site, use Content Manager to attach the source site to a destination site, and set **Merge** as the container level conflict resolution and **Overwrite** as the content level conflict resolution, the source language settings are not copied to the destination.
- Limited Access permission is not supported for restoring due to a Client API limitation. For example, in a source site, if you break the permission inheritance of an item, add a security group, edit the permissions (Limited Access permission is a mandatory selection by SharePoint Online), and use Content Manager to merge the source site to a destination site selecting **Merge** as the container level conflict resolution and **Overwrite** as the content level conflict resolution, the Limited Access permission is not copied to the destination.

- Audit settings are not supported for restoring. The source site collection audit setting cannot be backed up and restored to a destination. Due to limitations of the Client API, **Microsoft.SharePoint.Client.Site**'s attribute of **Audit**, **TrimAuditLog**, and **Site.AuditLogTrimmingRetention** cannot be retrieved during a restore.
- Personal View is not supported because it is a private resource and cannot be accessed by other users. For example, if you select a list as the source node, manually enter the list as the destination node, select **Merge** as **Container level conflict resolution** and **Overwrite** as **Content level conflict resolution** in **Wizard Mode**, select **Include list view**, and then run a copy or move job, the Personal View of the user who does not register site collections is not copied or moved to the destination.
