# AvePoint GroupHub 1.1

## New Features and Improvements

- You can now change group information by submitting a Governance Automation Online Change Group service request in AvePoint GroupHub.
- You can now create a group by submitting a Governance Automation Online Create Group service request in AvePoint GroupHub.
- AvePoint GroupHub Administrators can now configure **Governance Automation Online Integration Settings**.
- Office 365 group's Governance Automation Online (GAO) metadata can now be displayed as GAO tags of the group in AvePoint GroupHub.
- Office 365 group settings can now be configured in AvePoint GroupHub.
- You can now add tags to Office 365 groups outside AvePoint GroupHub using APIs and display the tags as Admin tags in AvePoint GroupHub.
- You can now view Governance Automation Online related information of an Office 365 group by clicking the **Governance Automation Online Information** button in the group card.
- Users can automatically log into Governance Automation Online to view requests when they click the **My Requests** link in AvePoint GroupHub.
- AvePoint GroupHub Administrators can configure whether or not to allow users to create Office 365 groups by configuring AvePoint GroupHub setting.
- AvePoint GroupHub Administrators can enable or disable the Governance Automation Online features in AvePoint GroupHub.
- Users can display Governance Automation Online related information (Basic Properties, Metadata, Policy, Lifecycle Timeline, and Service) of an Office 365 group.
- Users can now configure classifications for Office 365 groups in Group Settings.

## Known Issues

- The Governance Automation Online Create Group services where the **Available in service catalog (the Start a Request page)** option is deselected are still displayed in the service list and able to be selected for creating a group in AvePoint GroupHub.
- When you create an Office 365 group by submitting a Governance Automation Online Create Group service request in AvePoint GroupHub, and the request can be approved by the approver, the created group is not displayed in AvePoint GroupHub.  
**Root Cause:** The groups that are created via Governance Automation Online can be displayed in AvePoint GroupHub only when the groups are synchronized.  
**Workaround:** The synchronization job runs every hour after enabling group creation via Governance Automation Online in the **Governance Automation Online Integration Settings**.
