- The description and training topic of a question can now be displayed by clicking the corresponding icon when answering the question.
- Users can now remain in the **Need Review** page instead of being redirected to the **Need Answer** page when they select **Approve** or **Reject** when processing the selected answers.
- Added the **Breach Response**, **Cyber Security**, and **Microsoft GDPR Detailed Assessment** built-in question collections to AvePoint Privacy Impact Assessment.
- Project information can now be viewed using Microsoft Power BI.

Known Issues

- Users cannot change the IIS website if an APIA project is currently running. If a user needs to change the website, use the AvePoint Privacy Impact Assessment Configuration Tool to assign the IIS website, save the project as a new project, and then run the project.
- If a user installed AvePoint Privacy Impact Assessment with a built in database, a SQL Server instance is also created. If the user later uninstalls the product, the built-in database and SQL Server instance are not uninstalled and must be removed separately.
